Farmers who attend this course will:

- learn about the attitude, knowledge and management skills needed to manage safety on a farm;
- learn about the key requirements of health and safety legislation affecting farmers;
- know the major causes of accidents and ill health;

- know how to complete a farm safety risk assessment document;
- satisfy the farm safety training course requirements set out in the Targeted Agriculture Modernisation Schemes (TAMS) II terms and conditions; and,
- select to complete the course in person or online.
